The Thompson Valley Art League presents the 2008 June Juried Fine Arts Show from June 9 through June 27, 2008. The show is held at the Lincoln Gallery, 429 N. Lincoln Avenue in Loveland, Colorado. Contact Jeff Brooks at 970-663-2407 for information.

Eligibility;

Open to any artist working in listed categories. Works must be completed original art, not copied from published photos or works by other artists. They must be in good taste and have not received a cash award from any previous Art League sponsored shows. Installations not accepted.

Categories;

1. Oil Painting: oil paint and water-soluble oil paint.
2. Water media: gouache, tempera, casein acrylic & watercolor.
3. Mixed Media: soft pastel and oil pastel, pencil, charcoal, pen/ink, colored pencil, collage, mono-prints or combination of media.
4. Photography: includes digital enhanced or computerized works from artists original photo
5. Three dimensional: includes Bas Relief

Artwork not meeting above criteria shall be rejected.

Details;

Flat work must be wired to hang. **Flat work (including frame) shall not exceed 38 inches on any side.** Saw-tooth hangers, wet works and works exceeding these dimensions will not be accepted. Gallery wrapped paintings are acceptable as long as all sides are painted and no staples are visible. It is recommended that "gallery wrapped style canvas" be secured on 1 1/2" thick stretcher bars. Flat work to be hung cannot weigh more than 25 lbs. Attach label to the back upper right corner of work.

Three-dimensional works must be completed works, no more than 46 inches in any one dimension and weigh no more than 75 pounds are acceptable, artists may be required to provide a display stand. Relief works are considered 3-D & must be wired for hanging. All works must be clearly marked by labels from entry form.

For an additional fee of \$6.00 accepted artists may display (in protective covers), up to five matted bin works, no larger than 20 X 24 inches outside dimensions. Identify the works with artist's name, address, title, price, phone number and provide an inventory sheet of works. In the event an artist is not accepted for the show the bin fee will be refunded.

Sales

Sales will be encouraged to further the efforts of the Artists and to stimulate acquisition of original art by patrons and the public.

All works must be for sale and remain on display until closing of exhibit. Permission to reproduce entries through news media is granted by entering this show.

A 35% commission will be charged by TVAL on all sales. Payment of sold items will be made within two weeks after closing of the show.

Awards

A "Juror's Choice" cash award and ribbon will be given to one artist from the show. Cash and ribbons will be awarded for first, second and third place in each category.

Entries

Artists may submit up to three entries for a fee of \$10 per entry. Entry fee is not refundable.

Method of Entry

Only walk in entries of original artworks will be accepted for juroring. Items can be delivered to Lincoln Gallery during the week of June 2, 11 am to 4 pm. Entry deadline is Saturday June 7 at 1 pm.

Artists will be notified by phone of unaccepted pieces to be picked up the afternoon of June 7th. Only works selected by the juror will be displayed and eligible for awards from the show. **Unaccepted works** must be removed from the gallery by Tuesday June 10. A storage fee of \$3 per day will be charged until unaccepted works are removed.

Juror will select works to be displayed. Artists with **unaccepted entries** will be notified by phone between 2-5 pm on June 7. **Unaccepted entries** must be picked up between 2—5 pm on Saturday, June 7. (Please provide a phone number on the entry form where we can reach you that afternoon).

Shipping: Contact Shippers Supply in Loveland, CO, 970-663-2330 for information to ship artwork. Artists are responsible for shipping charges. In addition, there is a \$25.00 handling fee for shipment of artwork by TVAL.

- June 7** 10 am to 1 pm delivery deadline.
- June 7** 1 pm entries close, juroring begins.
- June 7** 2 pm-5 pm pick up of unaccepted entries.
- June 13** Show opens with 2nd Friday Downtown event
- June 13** Artist reception and awards 6 to 8 pm, award presentations at 6:30 pm.
- June 27** *Show closes*, artworks can be removed from the gallery after 2 pm.
- June 28** Displayed work must be removed from gallery between 11 am and 4 pm.

If prior arrangements are not made a storage fee of \$3.00 per day will be charged for artwork left after the juroring process and closing of the show. Contact Lincoln Gallery for pickup arrangements.

It is accepted by the submitting artist that; TVAL, members and hosting facilities will exercise all reasonable care in handling of artworks. TVAL / Lincoln Gallery shall not be held liable for damages or loss of any kind while work is being hung, displayed or during shipment.

Artist reception is Friday June 13, 2008, 6 to 8 pm in Lincoln Gallery located at 429 North Lincoln Ave, Loveland, Co.

Awards will be presented at 6:30 pm.

Opening of the show to the public is during Loveland's 2nd Friday 'Night on the Town' event June 13, 6 pm to 9 pm.
