Mission Statement: *"The purpose of the Thompson Valley Art League is to promote an enthusiastic pursuit of art; to encourage individuality and freedom of expression; to provide league members with opportunities to obtain public recognition, to advance to the public the knowledge, appreciation and practice of the arts, and collection of works of art."*

Members Meetings are the third Monday of every other month with the first meeting in January. Guest artists, demos or programs may follow the business session. Information is communicated through the lincolngallery.com website. New Active members' works must be juried and accepted by the board of directors. Any member may be reconsidered for displaying by the board if deemed necessary.

A 35% commission will be charged on all sales in the gallery or other venues arranged by the League/Gallery.

Active members have the opportunity to display on a monthly basis each medium for which they have been accepted. An active member retains voting and displaying privileges as long as the membership level requirements are upheld. Each member shall volunteer at Art in the Park, sit the gallery three times per year, attend three membership meetings, serve on one committee, and, when possible, participate in scheduled events during the calendar year. Other commitments beneficial to TVAL may apply toward the requirements as an active member. If an active member chooses to not sit the gallery, they can pay additional fees, as indicated below, but must still fulfill other obligations.

Non-active members may not display unless works are accepted in a TVAL juried show or special event. Non-active members will receive the newsletter, can serve on committees and may be asked to sit the Gallery if the need arises. Membership can be converted to Active Status at any time and receive displaying rights after works are accepted. Non-active members are encouraged to participate in activities and meetings; however, they are not eligible to vote on business matters of the League or Gallery.

Patron membership is non-voting membership not directly involved in the gallery, but may show support of the organization through: volunteer time, in-kind services or monetary donations. Monetary donations can be paid as a lump sum or quarterly and qualify for tax deductions as allowed by IRS regulations.

Renewing memberships shall be due and payable January 1 of each calendar year. If dues are not paid by February 15 of each new year, membership and privileges will be terminated. Reconsideration of membership will be as per the Policies and Guidelines.
