Mission Statement: *"The purpose of the Thompson Valley Art League is to promote an enthusiastic pursuit of art; to encourage individuality and freedom of expression; to provide league members with opportunities to obtain public recognition, to advance to the public the knowledge, appreciation and practice of the arts, and collection of works of art."*

- o Members Meetings are the Third Monday of each month - Guest artists demos or programs may follow a short business session, information is communicated through the Newsletter and Website.
- o New active members works must be juried by the Board of Directors and accepted for displaying. All members may be reconsidered at any time for displaying as deemed necessary by the Board of Directors.
- o A 35% commission will be charged on all Gallery sales, and in public places arranged by the League/Gallery.
- o Enrolled High School Students of Northern Colorado may be a member but will not serve alone as Gallery Attendants. Guidelines of Active / Non-active membership shall apply.
- o All members help with Art in the Park and other duties as per the Policies and By-Laws of Thompson Valley Art League.

Active Members have the opportunity to display on a regular basis after works have been juried and accepted by the Board of Directors. They may vote on League business at members meetings, help with Art in the Park, attend the Gallery at least 2 times a calendar year, serve on one committee, attend four meetings and encouraged to participate as a working artist during scheduled event in the calendar year. They must secure a replacement if unable to work their scheduled day from the list in the Gallery.

Other commitments beneficial to TVAL may apply towards the requirements as an Active Member.

A person may pay an annual \$120 fee and opt out of any duties and requirements as an Active member. Members working 5 calendar days above the defined requirements will receive the next years like membership free as per the Policies & Guidelines 5 Day Rule.

Non-Active members cannot display unless works are accepted in a TVAL juried show or special event. They shall receive Newsletters, information of League business, can serve on Committees and may be asked to attend the Gallery if the need arises. They may convert to Active Status any time and receive displaying rights after works are juried and accepted by the Board. We encourage them to attend meetings, but are not eligible to vote on business matters of the League or Gallery.
