Mission Statement: "The purpose of the Thompson Valley Art League is to promote an enthusiastic pursuit of art; to encourage individuality and freedom of expression; to provide league members with opportunities to obtain public recognition, to advance to the public the knowledge, appreciation and practice of the arts, and collection of works of art."

Members Meetings are the Third Monday of each month - Guest artists, demos or programs may follow the business session, information is communicated through the lincolngallery.com Website.

New Active member's works must be juried and accepted for displaying on a monthly basis. Any member may be reconsidered for displaying if deemed necessary.

A 35% commission will be charged on all Gallery sales, and in public places arranged by the League/Gallery.

**All members** help with Art in the Park or other activities when requested and available.

**Active Members** have the opportunity to display on a monthly basis after each medium they wish to display has been accepted. They retain voting and displaying privileges as long as the membership level requirements are upheld. Each member shall: help with Art in the Park, sit the gallery 2 times per year, attend three membership meetings, serve on one committee, and when possible, participate in scheduled events during the calendar year. Other commitments beneficial to TVAL may apply toward the requirements as an Active Member.

**Non-Active members** may not display unless works are accepted in a TVAL juried show or special event. They receive the Newsletter, can serve on Committees and may be asked to attend the Gallery if the need arises. Membership can be converted to Active Status any time and receive displaying rights after works are accepted. They are encouraged to participate in activities and meetings; however they are not eligible to vote on business matters of the League or Gallery.

**Patron membership** is a non-voting member not directly involved in the arts, but may show support of the Organization through: volunteering time, in kind services or monetary donations. Monetary donations are accepted as lump sum or quarterly and qualify for tax deductions as allowed by IRS regulations.

Renewing memberships shall be due and payable January 1 of each calendar year. If dues are not paid by February 15 of each New Year, membership and privileges will be terminated. Reconsideration of membership will be as per the Policies and Guidelines.
