Members can bring additional art and merchandise for the Gift Shop Expansion.

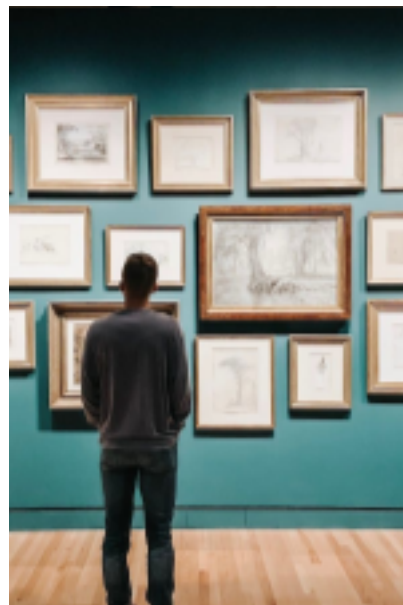
